Date: April 12, 2023

Call to order: The meeting was called to order at 9:38 AM.

New Business: President DeLapp reported that the FFAM convention will be in Springfield, MO and we will have a booth there on June 2. Members are welcome to come and assist with the booth. He also reported that there will be a battery storage class April 14.

Good of Order: Members present were encouraged to attend the activities for Firefighter Day at the Capital following our meeting, and the lunch afterward.
