**State Fire Marshal:** The Missouri Division of Fire Safety has partnered with the Fire Marshal's Association of Missouri (FMAM) to offer three final opportunities for Fire Inspector LL certification

before the next standard update. Please note, the next standard update will go into effect on January 1, 2026, so all students completing one of these Fire Inspector LL courses must have all certification requirements completed by December 31, 2025.

The Fire inspector LL course offers will be hybrid learning for the course curriculum and in-seat for skills. All three classes will start on July 1, 2025, with online portion ending August 30, 2025. Each class will have three skills days that will be required attendance at three locations around the state. Completion of the online portion is required to attend the skills days.
